Supplementary Terms concerning

Band 53

(v. 1.0 – applicable from 2023-11-03)

These Nokia Digital Automation Campus Supplementary Terms (the "Terms") apply to users of Nokia Digital Automation Campus platform (the "Nokia DAC") for wireless connectivity applications while utilizing Band 53 spectrum (2483.5 MHz – 2495 MHz, which is commonly called as S-Band in TDD) to which right to use is made available by Nokia directly or through Nokia Partner anywhere in the world.

Read these Terms carefully before using the Nokia DAC. By using any Nokia DAC applications that utilize the Band 53 spectrum, You agree that these Terms become part of the Nokia Digital Automation Campus Terms of Service between Nokia Innovations Ltd, or its Affiliate ("Nokia") specified in the order confirmation document issued by Nokia or authorized Nokia partner, and You as the individual, the company, or the legal entity using the Nokia DAC with the Band 53 spectrum (referenced below as "You" or "Your").

1. The Band 53 spectrum is a public licensed asset to which right to use is provided to You in accordance with Nokia's agreement with the spectrum license holder (the "Licensee") and subject to these Terms as well as any spectrum regulations that may be applicable where the Band 53 spectrum is used. Subject to Your continuous compliance with the applicable Band 53 spectrum regulation, decisions by competent authorities, and the Licensee guidelines for Band 53 spectrum usage You are provided with a limited right to use the Band 53 spectrum solely in connection to your Nokia DAC Subscriptions.

2. You agree that unless specific instance of Band 53 spectrum usage is portable, the physical location of the equipment emitting on the Band 53 spectrum is required to be provided to the competent authorities for compliance purposes, and therefore, You must not move or change the location of such equipment from the location of the original installation without prior approval of such authorities and the Licensee.

3. You shall grant Nokia, Your Nokia Partner (if applicable), and the Licensee, or their designated third-party representatives, access to the physical site at with Your Nokia DAC Equipment is installed but only to the extent that is required ensure compliance with the Band 53 spectrum regulations and obligations. You shall have right to require that inspection on your site is carried out under escort by our personnel.

4. Nokia with the Licensee may suspend or terminate Your right to use the Band 53 spectrum under these Terms if (i) You breach these Terms, (ii) Licensee loses the possibility to lease or otherwise grant right to Band 53 spectrum, or (iii) suspending the right to the Band 53 spectrum is required for Nokia or Licensee to comply with applicable regulation or applicable decision by competent authority.

5. Nokia reserves the right to supplement these Terms and guidelines concerning the use of the Band 53 spectrum if required to do so by Licensee or the regulatory authorities.
